It is a priority for Stats Perform to ensure that we trade ethically, source responsibly and work to prevent modern slavery and human trafficking throughout our organization and in our supply chain. This Modern Slavery Statement (“Statement”) highlights the key activities we have undertaken to combat modern slavery in our organization and supply chain. This effort is in alignment with our Environmental, Social, and Governance strategies to positively impact the communities in which we operate.

OUR SUPPLY CHAINS

Stats Perform’s primary operations are service-based products, which rely on the supply of communication and technology services, back-office resources, and IT equipment. Our suppliers are supported by many individuals with whom they engage, including couriers, engineers, and administrative staff.

Stats Perform has zero tolerance for slavery and human trafficking. We expect the same high standards from all our contractors, suppliers and other business partners, and we expect that our suppliers will hold their own suppliers to the same high standards. To ensure alignment with such standards, Stats Perform has implemented a **code of conduct** within our supply chain.

OUR POLICIES ON SLAVERY AND HUMAN TRAFFICKING

We have appropriate policies in place that underpin our commitment to ensure that there is no modern slavery or human trafficking in our supply chains or in any part of our business. We continuously review and update all our policies, which are made available to all employees. Our Anti-Slavery and Human Trafficking Policy reflects our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains.

Stats Perform employees are encouraged to report any misconduct or unethical behaviour, including incidents related to modern slavery, via our internal reporting channel in accordance with Stats Perform’s Whistleblower Policy.

STAFF TRAINING

Stats Perform provides periodic training and updates to its employees on key compliance initiatives, like modern slavery, including Stats Perform’s internal policies and procedures developed to address the risks posed by modern slavery and help raise and maintain education and awareness.

DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING

As part of our initiative to identify and mitigate risk, all Stats Perform suppliers are required to complete a supplier registration form.

We also have in place systems to:

- monitor potential risk areas in our supply chains; and
- protect whistle blowers.
